Citizens Clean Elections Commission Notice

**Notice to filers of independent expenditure reports**

Under A.R.S. §§ 16-941, -956, 958 and Ariz.Admin. Code R2-20-109(F) all persons who make independent expenditures related to statewide and legislative candidates are required to file reports of those expenditures.

Until recently, the Arizona Secretary of State's Campaign Finance Reporting System (<https://apps.azsos.gov/apps/election/cfs/filing/Login.aspx>) provided a login for persons who were required to file independent expenditure reports, but who are not political committees. That login is currently not available on the Secretary of State's login page for the Campaign Finance Reporting System. Additionally, we have no confirmation that political committees that do owe reports still have the ability to file independent expenditure reports.

The Secretary of State has not responded to written questions from Commission staff. Until this is resolved, all entities, including political committees, should use the form provided on the Commission's website (<http://www.azcleelections.gov/CmsItem/File/141>).

Daily starting two weeks before the General Election (10/25/16 - 11/8/16)	10/25, 10/26, 10/27, 10/28, 10/31, 11/1, 11/2, 11/3, 11/4, 11/7, 11/8

Additionally, as a reminder, entities who are eligible may seek an exemption from the Commission via the exemption form available on the website (<http://www.azcleelections.gov/CmsItem/File/87>).
